### **Section A: JOINTLY DEVELOPED**

Academy at Palumbo will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

- *Administration and Executive Board will work in partnership to develop with the School Planning Team, the School Improvement Plan for the School and update as needed. Parents will be notified and invited to discuss and develop the Improvement Plan and Federal Requirements addendum.*
- *The School will inform all parents of all school activities so they have opportunities to participate. Parents are informed through mailings, the school website, Naviance, the School Messenger telephone messaging system, emails and flyers. Written communication will be translated in other languages as needed.*

### **Section B: ANNUAL TITLE I MEETING**

Academy at Palumbo will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

## **Section G: BUILDING CAPACITY OF PARENTS**

  - Use the partnership of Home & School Association as a resource that will encourage and support parents in the education of their children and make parents aware of events and volunteer opportunities within the school to foster greater involvement.
  - Hold ongoing workshops pertaining to post-secondary options, including completion of the FAFSA and the college application process for junior and senior parents.
  - Provide information, resources, and seminars for parents on skill development, intervention programs, curricular goals, supports for students, and community resources.

#### **Section H: BUILDING CAPACITY OF SCHOOL STAFF**

Academy at Palumbo will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- Professional development opportunities will be offered to staff at both schoolwide and districtwide levels. Non-instructional staff are provided with an opportunity to learn and improve customer service. Working with parents will be a topic covered with staff during Winter PD on a district-designated PD day and parent survey results will also be shared with staff as part of that PD.
- Sharing best practices with staff during professional development when appropriate.
- Parents and teachers are able to share expertise during presentations with the Home & School meetings.
- Hold regular meetings for parents with a focus on topics as determined by the responses on the parent survey.

Academy at Palumbo will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

- Parent workshops facilitated by Bilingual Counselor Assistants and STEP personnel on topics generated by parent interest.
- Regularly reaching out to families via the principal's weekly update email to identify additional family engagement activities.
- Working in tandem with the Home & School to plan and support activities that promote further family engagement.
